# Pensacola Photography

- It is understood that no other professional or amateur photographer shall be allowed to photograph at the portrait shoot while our photographer is working.
- All proofs are yours to keep. All other photographic materials, including but not limited to negatives, digital files and transparencies, will be the exclusive property of Pensacola Photography, LLC.
- Safe Environment: It is understood that the contracting party is responsible for providing a safe and professional atmosphere for our photographers and other staff to work. If at any time our photographer feels it is an unsafe/unprofessional environment, the package will be considered complete and our photographers and staff may leave, and you shall not be entitled to any refund of the package price. It is also understood that our photographers will not work in environments outside the photographic equipment's designed working parameters.
- During indoor weddings, it is understood that no other professional or amateur photographer shall be allowed to photograph while Pensacola Photography's photographer is working. During outdoor/beach weddings, Guests are welcome to use cameras.
- No part of any order, including proofs or previews, will be delivered until the balance is paid in full.
- Pensacola Photography, LLC will follow any rules and regulations of the portrait location at or on public or federal, state, county, city, or other entity owned property, or private property.
- Pensacola Photography, LLC reserves the right to use photographs for display, website, portfolio, samples, promotions, editorial and promotional use.
- It is illegal to copy or reproduce these photographs in any manner without Pensacola Photography's permission, and violators of this federal law will be subject to its civil and criminal penalties. This includes scanning for printing or website use in any manner.
- Overtime: Because we may book another photographic session before or after yours, it is advisable that you book the package with the number of hours that best suits your event. Upon signature and receipt of your deposit, Pensacola Photography, LLC will reserve the time and date agreed, therefore all deposits are non-refundable. If the date of the portrait needs to be changed, we will review on a case by case basis to determine if the deposit will carry forward to the new date. If you must change the date, let us know as early as possible so we can review the case. In most circumstances, we can carry the deposit forward to a new date and time, provided we have that date/time available.
- In case of inclement weather, rain, tropical storm or hurricane prohibiting the photography and setup of outdoor session, Pensacola Photography, LLC will work with you to reschedule or relocate the session.
- Full value of the portrait session is earned two weeks prior to the event. Notice to cancel must be provided two weeks prior to the scheduled session. If portrait session is canceled, deposit is forfeited. If notice of cancellation is not given prior to two weeks of the portrait time, all charges are considered earned and are due. Cancellation prior to two weeks must occur through client speaking directly with a representative of Pensacola Photography, LLC, or sending an email to arrive prior to two weeks before the portrait date. The email address and phone number posted on Pensacola Photography's website at [www.pensacolaphotography.com](http://www.pensacolaphotography.com) will govern contact information.
- Pensacola Photography, LLC guarantees to have one of our professional photographers on time for your portrait. If Pensacola Photography, LLC cannot perform this agreement due to a fire or other casualty, strike, act of God, or other cause beyond control, including unavoidable traffic delays or mechanical failure, Pensacola Photography, LLC shall return the amount to the client but shall have no further liability with respect to the contract. This return of payment does not include situations where unavoidable circumstances may delay our arrival, and we have attempted to contact you en-route. This limitation on liability shall also apply in the event that the photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of Pensacola Photography, LLC. In the event Pensacola Photography, LLC fails to perform for any other reason, Pensacola Photography, LLC shall not be liable for any amount in excess of the retail value of the client's order.
- Client is aware that color dyes in photography may fade or discolor over time due to the inherent qualities of dyes, and client releases Pensacola Photography, LLC from any liability for any claim whatsoever based upon fading and/or discoloration due to such inherent qualities.
- The charges on this contract are based on Pensacola Photography's standard price list. This price list is adjusted periodically and future orders shall be charged at the prices in effect at the time the order is placed.
- Personal checks returned due to insufficient funds will be charged a \$40.00 fee, and remaining balances must be paid by credit/debit card, cash, money order or certified check. Any charges incurred to collect payment due Pensacola Photography, LLC will be the responsibility of the contracting party.
- Package enlargements, allowances, and other items included in the package or prepaid with this contract must be ordered within 120 days of the portrait date, or be subject to current standard prices, should the standard prices increase during the 120 days. Order instructions will be supplied to you upon delivery of your proofs, or are available online at [www.pensacolaphotography.com](http://www.pensacolaphotography.com).
- This agreement incorporates the entire understanding of the parties. Any modifications of this contract must be in writing and signed by both parties. Any waiver of a breach or default hereunder shall not be deemed a waiver of a subsequent breach or default of either the same provision or any other provision of this agreement. This agreement shall be governed by the laws of the State of Florida.
